School Mission Statement

The Big Wood School is a community of welcoming and nurturing educators, dedicated to ministering Christ's love and grace as we encourage each young person in his/her spiritual growth and provide professional guidance to develop each child's cognitive, social, emotional, and physical development. With the school, home and church working together, we become the anchor for effectively preparing students for life.

To reserve a space to attend the BWS, a \$100 registration fee is required at the time the contract is submitted, AS WELL AS FIRST MONTH'S TUITION. Both of these fees are NON-REFUNDABLE. Enrollment is considered complete when the contract, registration papers, copies of immunization records, and the deposit and first month's tuition have been turned into the school office.

1. The BWS will be open from 8:00 am – 5:30 pm, Monday through Friday. Days of school closure are: **Labor Day, one week for Thanksgiving, two weeks for Christmas Break and New Year's Day, Martin Luther King Day, Presidents' Day, one week at Spring Break, and one Staff Work Day on February 12th.** A school calendar will be distributed well in advance with all pertinent dates. **Tuition remains constant regardless of attendance. This includes illness, holidays, teacher workdays, and family vacations.**
2. Monthly tuition is due by the 5th of each month. Any extra hours, bus fees, and other additional charges are added on the following month's billing. Payments not received by the 15th of the month will incur a **2.5%** penalty. **Accounts that are a month delinquent will cause the cancellation of your child's enrollment.** All accounts must be cleared before re-enrollment.
3. All fees associated with returned checks are the responsibility of the parent.
4. Any contract changes must be in writing – days, weeks, times, etc. If you must unenroll your child prior to the end of the school year, **we require 30 days written notice** in order to make any necessary staffing adjustments. **Failure to provide 30 days notice will result in forfeiting one month's tuition.**
5. The BWS reserves the right to keep the school a safe environment for all. In the case of severe and persistent behavior problems, the school will follow the procedures outlined in the Parent Handbook. This may result in a child being dismissed from the BWS.
6. On or before the first day of school, all required paperwork must be filed in the school office.
7. Extra hours will incur additional charges at the rate of **\$8.00** per hour.
8. Siblings receive a **10%** tuition discount.
9. For children left at school after 5:30 PM families are charged at the rate of \$1 per minute per child.
10. Please be prepared to pick up your child if he/she becomes ill at school (See Illness section in handbook). Be sure to have a back-up person available for emergencies.
11. Parents are responsible for reading and understanding this contract and the parent handbook.
12. BWS reserves the right to cancel school for the day or longer when environmental or health factors impact the safety and/or well-being of our students, their families, and our staff, ie. Community spread of COVID-19, Snow Days, Dangerously Poor Air Quality, etc.
